NOTIFICATION

No. SOT(MMD)/3-5/2009/ 642-770 : In exercise of the powers conferred by Section 2 of the Regulation of Mines and Oils Fields and Mineral Development (Government Control) Act, 1948 (XXIV of 1948), the Government of Balochistan is pleased to amend the Balochistan Mineral Rules, 2002, namely :-

(a) For sub rule (4) of rule 3, the following shall be substituted:-

"Minutes of the meeting of the Mines Committee shall be recorded, and signed by all the members and shall be submitted to the Secretary Mines and Minerals Development Department. The Secretary Mines and Minerals Development Department, as final authority, may grant or refuse to grant Licence or to refer the matter to Mines Committee for reconsideration".

(b) After clause (b) of sub rule (2) of rule 77, the following new clause (c) shall be added:-

"(c) in respect of an area of land, an application not supported NOC from the concerned district Collector / Authorities"
